## **Workshop #1 - Masters Handling:** For teams working at the Master/Excellent level.

This class will take your handling to a new level. We will look at timing and most efficient handling options along with high level skill work and planning. Work toward better handling execution in addition to working out of the comfort zone with challenges on course. From 9am to 1pm. Cost is \$90. Limited to 8 dog/handler teams.

## **Workshop #2 - Young Dog:**

This is focused on the young dog just approaching novice or sequencing. Exercises focus on teaching the dog how to think through a sequence by watching handling cues. We will work jumping skills, contact performance and motion based handling. From 2pm to 5pm. Cost is \$75. Limited to 8 dog/handler teams.

### *Marisa's Bio:*

Marisa has been training dogs for over 10 years. She started with German Shepherds and a Border Collie and now also runs Japanese Chin. She focuses first on the handler dog relationship and then on the handling. She believes that once a trusting and fun relationship is established, anything is possible. Marisa uses a motion based handling system.

#### **Marisa's dogs include:**

**MACH 4 Draven CD** is the first MACH rescue German Shepherd. He's a 2X National Agility Specialty Winner, 2X National Agility Invitational Finalist.

**MACH 3 Ch Kamikaze**, is a breeder/owner-handled champion. She is also the first and only MACH Chin.

**Tangy MX MXJ XF** is well on her way to a MACH and won the Top 20 GSDCA Invitational in 2010

**Chrissy NAJ** is her newest Japanese chin and recently earned her NAJ

**Rev** - Baby GSD in training.

Directions: Route I-495 (LIE) east/west to Exit 43N (South Oyster Bay Road) or Northern State Parkway east/west Exit 36N (South Oyster Bay Road). Take South Oyster Bay Road north. Cross Jericho Turnpike (Route 25). The road now is called Jackson Avenue. Continue straight across LIRR tracks into Syosset Village. Bear left at the 2nd light after the tracks (BP station). Bear right at the five-way intersection onto Berry Hill Road. Pass Dairy Barn on the left and 7-Eleven on your right. First left onto Church Street. (Beney Funeral home on southwest corner). Turn right into the second driveway and drive to the rear parking area. (Note: 5 mph speed limit!)

We train in the rear building at the top of the stairs.
