From the North

Take I-91 to West Springfield - Exit 13S (Sign reads "Route 5, Riverdale St., West Springfield"). South on Route 5 to Route 147 West. Follow Route 147 West for 1 mile to Show Grounds and "DOG SHOW" sign on left.

From the South

Take I-91 North to Springfield - Exit 3, Mile 4 (Sign reads Route 5, Columbus Ave., Agawam, West Springfield).
Follow Route 5 North to Route 147 West, then as above.

From the East or West

Take Mass Pike (I-90) to Exit 4. Follow signs marked "Route 5, Riverdale St., West Springfield". Take Route 5 South to Route 147 West, and same as above.

Day-of-Match entries will be accepted starting at 3:00 p.m. and close at 5 p.m. EDT on Saturday, August 28th, 2010, after which time entries cannot be accepted, cancelled, or substituted as provided in Chapter II, Section 6, of the Dog Show Rules.

Major pointed dogs are eligible for competition. AKC Champions of Record may not be shown. Professional handlers may enter provided they own the exhibit.
